

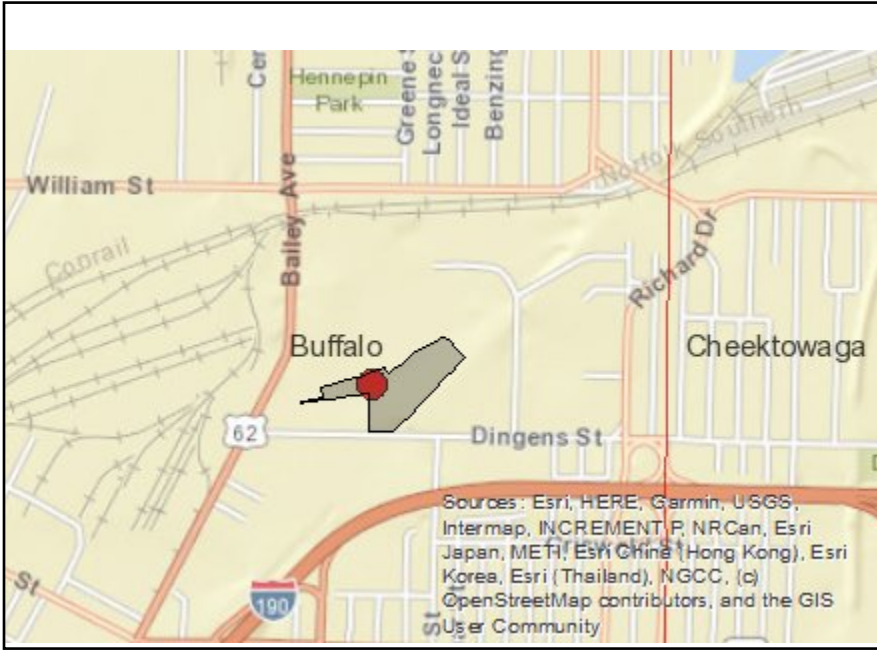

Brief Description of Proposed Action: The project includes the construction of a 13,300 sq. ft. metal building, constructed using a pole barn method to limit soil disturbances to the foundations for the poles and utility trenches, while the remainder of the building will have the existing pavement remain, with new floor slabs being constructed over top. The building will be located towards the rear of the property. Internal spaces consist of an office, a shop, and storage. The shop and storage will be accessed through a total of 5 overhead doors, and the office by one man door with a pair of windows for daylighting.
